



Extract of CAVB Competition Regulations – For participants in the African Nations Championships

I – composition of the Delegation

According to the CAVB Regulations each delegation is composed of 21 persons constituted as follows:

Team manager – Head Coach – Assistant Coach – Trainer/2nd Assistant Coach - International Referee – FIVB accredited Doctor - FIVB accredited Therapist - 14 players.

Should any one of the functional positions not be filled by the properly authorized or accredited person, that position cannot be transferred to another function or person, therefore the official delegation will be reduced accordingly.

Each team must compulsorily be accompanied by an International Referee nominated by CAVB. A team, which has no referee in its delegation, will not be allowed to participate in the competition unless they pay all the expenses required to hire another referee from the nearest country.

Teams participating in a championship may arrive preferably a day before the Technical Meeting and should leave one day after the championship.

Any team that arrives for the championship after the technical meeting will not participate in the competition.

II – Players

National Team Players who must represent their country in African and International Championships should show evidence of their Nationality by producing a valid passport.

The naturalized players can take part in the African championships by presenting proof of their stay for two years in the country that recently granted them their new nationality and present FIVB approval letter.

For championships with age limit, the individuals' national passport is mandatory.

Professional players playing abroad are allowed to play for the National teams of their countries.

Professional players playing for clubs outside their country should be released no less than 15 days before the beginning of the competitions. If such a player fails to be released the aggrieved National Federation shall approach the CAVB to intervene in the matter.



III - Financial conditions of the participation:

1. The participating teams pay a sum of **1,000 US\$** to CAVB as participation fees. In case of non-payment of this fee by a team, the concerned team will not participate in the championship.
2. The participating teams pay to the organizing Federation the amount of fifty **US\$ (50 US\$)** per day for each member of the delegation (up to 21 persons) including the international referee accompanying the team.
3. Fees per person per day are calculated from the day of arrival to the day of departure (not by night).
4. In case of early arrival or late departure and or any extra member/s of delegation exceeding the contingent of twenty one, the participating expenses will amount to seventy five **US\$ (75 US\$)** per day and per person.
5. Any participating team in the competition whose equipment has advertisement other than the FIVB homologated manufacturer's logo or is wearing advertisement on their uniform and/or accessories must pay to CAVB one thousand U.S dollars (**1000 \$**) for each of the advertisement.
6. The team that withdraws from the championship after its commencement will not be exempted from paying or be refunded the **50 US\$** payable to the organizer per day for each member of delegation or the **75 US\$** for any extra member/s of the delegation. They will also forfeit the participation fee paid to CAVB.
7. Any team willing to change its residence from the designated teams' residence will be responsible for full cost of such relocation expenses; as well as fees due to the organizer (**50 US\$** per person per day). The team will not be refunded lodging fees that were already paid to the organizer.

VI - UNFORESEEN ITEMS

As regards specific items not expressly foreseen in the present extract regulations, reference is to be made to the CAVB competition regulations, constitution and FIVB regulations.
